The following is the School Resource Officer Report for March 2019.

On Tuesday, March 5, through Thursday, March 7, Officer Aaron Zuhl and I attended training at the Columbus Police Academy. The training was regarding leadership in modern policing. This training, while focused on leadership within the department, had many good ideas on handling issues that may arise in many parts of our jobs. While we were at this training, Officers Hickman and McNeil covered the school to ensure a law enforcement presence during the day.

On Saturday, March 9, the Covington Noon Optimist and Kiwanis Club held their annual Pancake Day fundraiser at the Covington Schools Cafeteria. This year, we saw a good sized increase in the number of meals sold, as well as overall net profit. The Optimist Club is donating their entire profit from the event to the Village of Covington to assist with reconstruction of the village basketball courts that are used by many children and adults in the community.

On Thursday, March 14, Wednesday, March 18 and Wednesday, March 20, I spent time with our Kindergarten classes in the Elementary Library as they learned about safety through a series of books that were read to them.
