The following is the Covington School Resource Officer Report for August 2019.

August begins the fifth year of the full-time SRO Position at Covington Exempted Village School District. In addition, we are training Officer A.J. Hickman to take over the SRO Program due to my promotion to Sergeant. Officer Hickman attended the Ohio School Resource Officer's Association Basic SRO School at the Columbus Police Academy at the end of July. I will remain in the schools in some fashion with Officer Hickman through the remainder of this school year.

As always in August, we had numerous events leading up to the start of the school year. On August 9, I attended the Miami County Safe Communities Coalition's "Drive Sober or Get Pulled Over" Kick-off Event held at Troy Christian High School. During this year's event, AAA Student Driver Program was on hand and had Driver's Education students from Troy Christian complete a driving course three times. First, the driver had no distraction, second, the driver had Fatal Vision "Drunk Goggles" on, and lastly, the driver was texting throughout the course. These evolutions through the course helped show the students the dangers of driving impaired or distracted.

During the week of August 12, I met with the School Administration multiple times to prepare for the start of the year. On August 16, the first teacher work day, I assisted our school nurse with CPR Training for staff members. Later in the day, I did the annual A.L.I.C.E. Refresher training. This is also the fifth year of Covington staff getting this training on Violent Intruder Events.

On August 19, the second teacher work day, I again assisted the school nurse with CPR Training for staff members. Later that evening, Covington Schools held their annual Open House for all grades. I assisted the District's Technology Department with handing out Junior High and High School students' assigned Chromebook computers. This allowed me to see and speak with the vast majority of our Junior High and High School students and their parents. Chief Harmon and Officer Hickman were also present during the event.

August 20 was the first day of school, in addition to myself, Chief Harmon, Officer Hickman, Officer Russell McNeil and Officer Alyssa Baker were all present for at least some of the day at the schools.

On August 28, Covington High School held their first Truancy/Absence Intervention Meeting of the year with a High School Student.
